Tucumcari Project Office

CN4101390 - Interstate 40, Mileposts 344.5 to 350 (Between Tucumcari & Santa Rosa)

Cost: \$22,500,000.00

Contractor: Fisher Sand & Gravel

Scope of Work: Roadway Reconstruction and Bridge Rehabilitation operations will be performed on both the east and westbound lanes of Interstate 40. Construction includes a mill and overlay, replacement of metal barrier (guardrail), new fencing, bridge rehabilitation, installation of underdrains, and placement of new permanent signage and striping.

Status: This project is currently ongoing.

Hours of Operation: 6 a.m. to 6 p.m., Monday through Friday.
